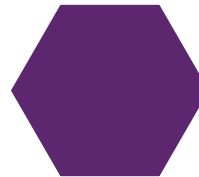
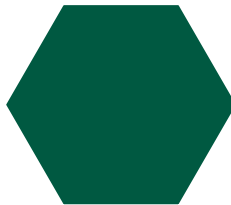

**PN to RN bridge classes consists of NSG115 and NSG200 and are day only in the fall session in Hampton. NSG115 is not Financial Aid eligible. After completion of these bridge classes, students will declare preference for day or evening/weekend RN program and join 3<sup>rd</sup> semester RN students at the Williamsburg Campus in January or at Hampton in August. Advanced standing credit will be awarded for 1<sup>st</sup> and 2<sup>nd</sup> semester RN classes.**

## Steps to Admission

### Step 1: Apply to the College and Submit Official Transcripts

The on-line application for admission to the College is available at [Virginia Peninsula Community College — Introduction \(vpcc.edu\)](https://www.vpcc.edu). Official high school transcripts, GED certificates, and official college transcripts must be sent for evaluation and award of transfer credit.

**PN education transcripts and current PN license are required.**

### Step 2: Take College Placement Tests

As determined by placement on these tests, satisfactorily complete all required developmental courses prior to application.

### Step 3: Complete the Nursing Program Prerequisite Requirements

- High School Chemistry: One year required with a final course grade of “C” or higher OR satisfactory completion of CHM 01, CHM 101, or any higher-level CHM course.
- High School Algebra: One year required with a final grade of “C” or higher OR satisfactory completion of MDE classes or any higher level MTH course. MTH154 will satisfy this requirement.

In addition to the high school prerequisites, the following courses must be completed with a grade of “B” or higher

Applicants must have a minimum prerequisite GPA of 3.0 or higher at the time of application to the program. Only the pre-req course grades are used to calculate the prerequisite GPA.

**Important Note to All Transfer Students:** No transfer credit shall be given for courses with grades lower than “C”. For Nursing Application, grades must be a “B” or higher. Grades earned in transfer courses will be included in the prerequisite GPA.

### Step 5: Attend a Nursing Program Information Session, References and Resume

Information sessions are **strongly recommended** and will be virtual. Presentation slides, Zoom links and directions are posted on the Nursing Applications webpage.

Request a reference from a BIO/HLT instructor or other as needed. They will be sent a link/email from NursingCAS to submit your reference directly. A separate reference form or letter is not required.

Resumes for work history, allied health experience or military service will be part of your [www.NursingCAS.org](http://www.NursingCAS.org) application in the EXPERIENCE section. No need to upload a separate resume.

### Step 7: Complete/Submit the Application

Complete the on-line application at [www.NursingCAS.org](http://www.NursingCAS.org). Application fee of \$55 applies.

Please upload a copy of your high school transcript and additional transcripts for coursework at other colleges are uploaded to NursingCAS.

Please ensure your reference provider is expecting an email from NursingCAS to submit a reference directly.

Please complete the EXPERIENCE section for your work history, allied health experience and military service.

### Step 8: Complete Pre-Admission Testing

ATI TEAS exam ([www.ATItesting.com](http://www.ATItesting.com)) is required for admission and will be scheduled separately from the NursingCAS application. TEAS must be taken at the College and will take place at the Hampton campus at the end of each application period. The scores are good for one year. A fee of \$65 must be paid on test date. Please bring photo identification and credit card with you on test day. A minimum score of 45% for the Percentile Rank across all ADN programs must be achieved for application to be considered. Remediation and preparation for this exam is highly recommended. Study guide is available to purchase at <https://www.atitesting.com/teas/teas-prep>. ### Acceptance

All students who apply to the nursing program will be notified of their admission status by mail. Students applying for PN-RN Bridge classes will be notified by mid-March. There are two types of acceptance: conditional and alternate.

**Conditional Acceptance:** All students who are awarded conditional acceptance must attend a mandatory orientation session to receive information regarding submission of a physical requirements, validation of current American Heart Association’s Healthcare Provider CPR, and a criminal background check and drug screen. Failure to satisfactorily meet all of the requirements by the due dates identified will result in cancellation of acceptance status to the program.

**Alternate Status:** Status awarded when the number of applications that meet requirements exceed the number of students that could be accepted. Accepted students sometimes decline admission, and attrition occurs, so alternate students are offered conditional acceptance. Alternates not admitted must reapply in the next admission period, must maintain a minimum prerequisite GPA of 3.00, and must retake the HESI A2 test or use previous test score (within one year).
